


CAFAS® Total Score The CAFAS Total Score is the sum of the impairment ratings for the 8 subscales for the youth. For each subscale, the rater selects the item(s) which are true for the youth, which in turn, determines the youth's level of impairment for that subscale. There are four levels of impairment: Severe (30), Moderate (20), Mild (10), and No or Minimal (0) Impairment. A higher score indicates greater impairment.





CAFAS Tiers © CAFAS Tiers is a classification system based on the youth's profile of subscale scores. The CAFAS Tiers grouping can be helpful in matching a youth's needs to the most appropriate and/or effective treatment protocol. It is a hierarchical system, such that the youth is assigned to the first tier to which he or she meets the criteria. The nine mutually exclusive "client types" are arranged such that the first ones considered are those that may need specialized care and/or generally reflected more salient impairment. This information can be useful in program development, with the aim of ensuring that youths receive the services they need in order to improve their functioning. For the algorithm used for determining CAFAS Tiers categories, refer to the CAFAS Manual for Training Coordinators, Clinical Administrators, and Data Managers or the Evidence-Based Treatments for Children and Adolescents: A Compilation of Resources and Guide for Matching CAFAS Profiles to Evidence-Based Treatments.



CAFAS® Clinical Markers

- 49.2% of youth have one or more Severe Impairments (score of 30) at initial assessments.
- 34.3% of youth who have Pervasive Behavioral Impairment at initial assessment. These youths are severely or moderately impaired on three CAFAS subscales: School, Home, and Behavior Toward Others. The families of these children may need specialized treatments, enhanced services, or additional supports in order to observe improvement in functioning.
- 42.5% of youth who may potentially benefit from their caregivers improving their Child Management Skills (e.g., PMT), as part of initial treatment. These youths are severely (30) or moderately (20) impaired on the Home subscale, with no severe co-morbidity (i.e., no severe impairments on the following scales: Thinking, Self-Harm, Mood, and Community).
